### **SALT LAKE COMMUNITY ACTION PROGRAM REPLACEMENT WINDOW BID 2010**

The Salt Lake Community Action Program (SLCAP) is accepting bids for the purchase of replacement windows for use in its Weatherization Assistance Program (WAP). We are asking for the price for windows only not installation. Installation will be preformed by our in-house crews. The windows will be used in the agency's Weatherization Assistance Program (WAP). The WAP provides energy efficiency upgrades to low-income people's homes, at no cost to them. Our service area is Salt Lake County and Tooele County. SLCAP is a 501 c(3) non-profit corporation and a licensed contractor.

Over the course of a year we expect to purchase over \$180,000 worth of windows. Almost all windows will have to be custom made as they will be used in a retrofit application.

Over the last two years we have ordered the following types of windows: Single Vent Slider (57%), Single Hung (28%), Fixed (5%), Double Vent Slider (4%), Sliding Glass Doors (4%), Casement (2%). All with Low E Glass.

**Bid requirements.**

Bids must be received no later than 4:00 pm on June 30, 2010 at the SLCAP offices located at 764 South 200 West, Salt Lake City, Utah 84101. Mark the outside of the bid package "Replacement Window Bid 2010".

The bid must include the following:

Documentation that the windows meet the above standards . And a statement that all widows purchased during the purchase agreement term will meet these standards.

A copy of the most recent independent tests done on the products offered in the bid.

Documentation of the compan'sliability insurance with coverage amounts listed.

Certification that neither it nor its principals is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation by any Federal department or agency.

A statement that if successful the bidder will abide by these terms throughout the term of the purchase agreement.

Information regarding your company, such as its size, annual production, how long you have been in business and anything else that shows the strengthen of your company.

A description of your billing process and what our payment terms will be.

A description of the ordering process we will follow. Be sure to include the turn around time from order date to window availability. Also state when we must pick up the windows after they are ready. Be aware that we do not have the ability to warehouse windows.

Documentation of the warranty on each type of product bid.

A statement indicating the variance from the ordered size that we can expect.

Complete these tables for each window model you are bidding on. Also provide information about the materials used in each model, including the specifications of the Low E Glass if included.
