Subject: Existing Inventory of GE Hybrid Water Heaters

Basis: Section D1.1.b.i

Purpose: Provide guidance for agencies that have existing inventory of GE hybrid water heaters.

Scope: This guidance applies only to existing inventory of GE hybrid water heaters. This does not authorize the purchase and installation of new appliances.

Responsibilities:

Local Agencies –

- Agencies with an existing inventory of these appliances may install them as a fuel conversion from propane.
- They should be audited as a conversion using the WA 8.9 audit tool. See attached examples for the necessary information to enter.
- You are authorized to turn the water heater measure on in the audit tool for those specific audits and are not obligated to document that on the Audit Setup Library Change Log.
- Notify State WAP office of current inventory level of GE hybrid water heaters.

State WAP Staff –

- Provide local agencies technical support as requested.
